













Gengi rúblu gagnvart millardíkjadollar 1. nóv 2015 - 19. nóv 2016




Vörubiðskipti EU og Rússlands 2013-2015 í milljörðum evra




Þjónustuviðskipti EU og Rússlands 2012 -2014 í milljörðum evra
